marketing items big and small fall into this group. I hope to focus on welcoming U7 families and helping them to feel truly a PART OF the Hawks. Looking to create a welcome package for new players. Launching "sibling colouring sheets" this year and a photo op sandwich board at early U7 ice times that says "My First Day of Hockey." Merch will expand via print-on-demand to include options for everyone and we will push this as a gift idea closer to December.

Overall the coaching and assistant coaches were placed really well. Tiers 1 through 5 all did really well. Lots of great volunteer support for pathways, evals. Moving to the future – connections with/between coaches, mentorship. Tier 1 and 2 players are always asking about HADP/AA etc. The question is always "How do we retain these players after their second year in U11?" Agree that volunteering commitments all starts at U7/U9. 8.7.4 U13 - Jean-Marie Robert Tiering overall was pretty good. Nothing glaring, 504 was mis-tiered but got it sorted. 501 went to Tier 1 and stayed there. Always need to be conscious about being competitive on the ice - winning some and losing some. Not too much of either. Depending on our numbers, we will probably have a wide range of skill within each team. Liked how evaluations went. Some adjustment with the referees - adults not kids.

# HAWKS ATHLETIC CLUB – 2024 AGM PRESIDENTS REPORT

This year began with a lot of transition. Needing to find executives to fill out the board proved to be the primary task. Shaun Maslyk was the first to be approached for VP-Development/Coaching. He has not disappointed, spear heading Hawks on ice coaching and off ice coaching workshops and chairing our evaluations contractor committee in preparation for coming seasons. Next we needed a VP Finance and Ademola Ajidagb stepped forward and has been integral this season not necessarily with his finance acumen, but with identifying all of the financial blind spots we continued to uncover.

As the season began, there was a discovering of shortcomings with accountability with regards to off ice administration. The decision was made to move forward and begin to plan for a transition from Lorraine as Registrar/ED and begin the search for a new ED. The executive met with other organizations, employment lawyers and met to vote on moving on from Lorraine.

The search began with reaching out to our membership and with a considerable amount of interest, we believe we found the one individual who will help the organization get back into good working order and then transcend the club beyond elected board members and provide consistency, direction for members, for years to come. With Sarah Baker, we believe we found that individual and over the last two and half months, the changes have been uncanny with so many processes already in place and as we sit here, the sky is the limit with Sarah. We are in good hands.

# Hockey Edmonton Board Changes

In June2024, the unanimous vote initiated the change of Hockey Edmonton's board structure from having zone's, elite clubs and condensed the Board to 7 to 9 independent board members. The search for members is underway and will look to implement the new structure in ~6months time. This move is beneficial for the Hawks as we will be part of the 'Community' Hockey committee which will give us a vote on all matters that affect the club a higher level. More to come.

# Hawks Athletic Club 2024 AGM

# Shaun Maslyk - VP of Player Development and Tiering

# 1. Player and Coaching Development:

Our mission is to provide valuable resources for all Hawks Athletic coaches, ensuring consistent development across our organization and for the members we serve. We are dedicated to helping coaches elevate the players' experience while supporting and collaborating with them every step of the way.

# 2023-2024 Over Goal:

During the 2023-2024 year my aim was to begin establishing a "coaching way of being" for the Hawks Athletic Club. This means taking a "coach approach" to the way we think about the game. Coaching is a transformative process that requires coaches to intentional focus on the players (the devil is in the details). A coach is most effective when they can help a player understands "why" and "how" we are doing specific drills, practicing specific skills etc.

We don't just want to let players run through drills or just let them out on the ice, we want to help guide them in becoming the best player they can. Coaching is a word we often use without much thought; however, the essence of "coaching" is very important and requires great attention. I believe player development starts with coaching development, ensuring that our coaches embody the coaching mindset. In 2023-2024 the goal was to start introducing coaching clinics, structures to practices and ensuring coaches understood the value of their role as a coach.

Furthermore, we know that volunteers are busy individuals, and they want to do the best they can, however, coaching can be overwhelming so we wanted to provide assistance and structure to the coaches. Providing them with manuals and guiding principles.

# **Reflection:**

Originally, I assumed that we could create, organize and develop these manuals, however, it has taken more time than anticipated. Time to collect data by observing practices, interacting with other coaching, and getting everything into a manual.

The foundational work has been done in 2023-2024 and now in the 2024-2025 the goal will be too full integrate the manuals. A large part of my time in 2023-2024 was spent creating drafts of the manuals and documents, now we can implement these manuals.

- September 2023: Held an on ice and off ice coaching develop clinic:

- **Aim:** To show coaches specific hockey skills and "how to teach" critical skills for player development. The office section was focused on how to establish your own way of being as a coach. The importance of establishing a coach like mindset and skills to ensure players are being coached to develop and succeed all while having fun.
- o Skills
- **November 2023:** Held an off-ice coaching development session aimed at teaching how to construct proper practices to maximize player development.

# 2024-2025 Commitments:

- Skills Development Sessions:
  - To establish a weekly (12 weeks) skills development program for U9, U11, and U13. These sessions will be offered to Tier 1 and 2 of each division with the intent to develop and enhance skills.

# - Coaching Guiding Principles:

 To implement across all divisions our organizations coaching guiding principles which will reflect and the mission and values of the Hawks Athletic Club. Successful hockey clubs start with clubs who share common goals and missions.

# - Category Coaching Manuals:

• To provide each division with their own coaching manual which will have details on how to be as a coach, how to coach skills, drills explanations, how to coach drills etc.

# - Video Archive:

• To successfully create and implement a video library of drills and skills explained in detailed but short form (40 videos)

# 2. Evaluations and Tiering

We created a committee to evaluate and examine the results from Sports Evaluation's evaluation for the 2023-2024 season.

# The Desired Goal:

"How do we create an evaluation process that is fair, reliable and consistent so the Hawks players are placed within appropriate tiers based on their proficiency?"

# Cost:

On a 3 Year Term, the price would remain the same as last year and 3 additional years. \$16,900 + GST up to 250 Kids Evaluated. (\$70 per player additional)

For a 1-year term – there would be a price increase of 5%.

# Decision:

To sign with Sports Evaluation for a 1-year extension. During this year, we will work closely with Sports Evaluation to determine if we will commit to a longer partnership.

# **Rationale:**

After the following investigation, we have decided to proceed with a 1-year commitment with Sports Evaluation. We had hesitations about signing for 3 years since the consensus was that we wanted to test out Sports Evaluation for one more year in order to see if they will collaborate more with the category directors, which we collectively feel will help with the evaluation process. Our top priority is to focus on transparency. We want the process to be extremely transparent for the category directors, the parents, and the board. Justin has committed to providing the Hawks with as much transparency as possible. Regarding costs, we determined that the 5% price saving (by signing for 3 years) wasn't a substantial savings, as we were concerned about being stuck with Sports Evaluation for 3 years if the process does not go well.

# The decision was made through:

• Consultation with category directors, conversations with Justin from Sports Evaluation, and discussions with SWAT's player development director.

# Keys to Success:

- 1. All members who have children within the Hawks will be sent an email providing details of the evaluations (1st Communication).
- 2. A social media post will be directed to bring awareness to the members to watch out for the emails with all the information pertaining to evaluations (2nd Communication).
- 3. A further email will be sent to member parents (similar to the first email) (3rd Communication).

- 4. During player evaluation check-in, parents will receive a hard copy of the evaluation process.
- 5. Category directors are fully aware of the evaluation process.
- 6. Any questions, concerns, or comments will be directed to category directors. If they need to escalate the issue, Shaun Maslyk (Evaluations) will be contacted. Should Shaun need assistance, he will contact Justin from Sports Evaluations directly. Shaun will keep Graham and Shawn Melnyk informed.

# 2024-2025 Commitments:

Communication will be critical this year. We want to over communicate, if possible, with evaluations this September.

- Communicate in detail when evaluations will take place as soon as we get confirmation from the city to our ice times.
- Inform Justin from Sports Evaluation as soon as our times are confirmed.
- Email the parents details about the evaluation process. This means sharing all relevant information from Sports Evaluation such as the drills that will be in the evaluations, Sports Evaluation process, the FAQ on Sports Evaluation's website
- Clear communication that any questions, concerns or comments pertaining the evaluation process need to be directed at the category director. The category director will have the FAQs, and other information that will be shared from Justin. If the category director can not solve the issue, they will contact Shaun Maslyk who will try and solve the issue, and if not, Shaun will contact Justin.
- Key to success:
  - o Communication with the parents, category directors and Justin


# ACTION ITEMS 2024-2025


- Hawks Equipment order and Timbit gear will be made at the end of July.
